- ◆ Fee is \$250 for 2-days, Electric Provided.
- ◆ Booth Space is rented on a "first come-first serve" basis.
- ◆ \$125 nonrefundable deposit is required with Application.
- ◆ Balance of fee must be received by August 15, 2010. **NO REFUNDS**
- ◆ Must be a licensed wine or brewery vendor and show proof of liability insurance.
- ◆ RIAF 2010 Oklahoma Wine & Brewery Tasting portion will be held indoors.
- ◆ Booths may be set up from 6 am - 9 am Friday Oct. 1ST
- ◆ Vendors must be available & in attendance 10 a.m.- 8 p.m. both days.
- ◆ All sales are to be handled individually by each exhibitor.
- ◆ Exhibitors are responsible for collecting and reporting sales tax, as required by law.
- ◆ All vendors must reserve booth space prior to the event date. No one will be permitted to sell on the grounds without reserving a booth.
- ◆ **VENDORS MAY ONLY SET UP IN SPACE ASSIGNED.**
